### A . PERSONAL EFFECTS include the following goods:

Wearing apparel; and Personal goods of a type normally carried by a passenger, including jewelry, toilet requisites and similar personal goods; and

Professional instruments, apparatus and implements.

### If the goods -

- are owned by the passenger at the time of his arrival in Fiji, have been used and are for his personal use; and
- 2. are not intended for gift, sale, barter, trade or exchange; and
- are imported into Fiji before the expiry of twelve months after the date of the arrival of the passenger

## B. HOUSEHOLD EFFECTS include the following goods:

Glassware, linen, cutlery, furniture, sewing machines and other household machines, gardening tools and similar household goods.

#### If the goods -

- are owned by the passenger at the time of his arrival in Fiji, and are for the personal use of himself and his immediate family; and
- are not intended for gift, sale, barter, trade or exchange; and
- are imported into Fiji before the expiry of twelve months after the date of arrival of the passenger; and
- in the case of Returning Residents of Fiji have been owned and used by such passenger for a period of twelve months prior to his departure for Fiji.

NOTE: - PERSONAL OR HOUSEHOLD EFFECTS do NOT include alcoholic beverages, tobacco goods, boats, firearms, motor vehicles, motor cycles and scooters.

# PENALTIES FOR FALSE DECLARATION ARE PROVIDED IN THE CUSTOMS LAWS

### **IMPORTANT**

Firearms - The importation of firearms, including air guns, air pistols, ammunition and explosives is prohibited except under licence issued by the Commissioner of Police.

Animals and Plants – The importation of live animals or birds, animal product, plants, plant material, fruit or seeds is prohibited except with the written permission of the Director of Agriculture.

Dangerous and Narcotic Drugs – The importation of dangerous drugs and narcotic drugs is prohibited except under licence issued by the Secretary of Health.
